Last year’s conference drew law enforcement and school personnel from over 20 States. As the L.E.A.D. program has grown this year, we expect even more national attendance. L.E.A.D. will be giving prizes and raffles for those in attendance so we request that all Exhibitors provide a giveaway to highlight their business. Giveaway items should be valued at a minimum of \$100. We will be drawing door prizes and recognizing our participating vendors at every general session, during the vendor reception, and at the closing ceremony.
